OBJECTIVES OF THE PROGRAMME :

To support high-burden countries to ensure evidence-based policies and strategies are in place to achieve universal access to high quality health services for Maternal, Newborn Child and Adolescent Health (MNCAH), and increase coverage and quality of effective interventions among pregnant women, newborns, children and adolescents, and to create mechanisms to measure the impact of those strategies.

Description of duties:

Provide technical expertise on indicators and tools for assessment and monitoring quality of care in MNCAH and the use of findings for quality improvement. Link quality of care indicators to the coverage indicators and provide cross cutting analysis with coverage data and take a lead role in the compilation and publication of the biannual quality-of- care-report in MNCAH. Provide technical expertise within the team on indicators for the facility-based assessment of quality of care. Review and adapt existing tools and/or develop new tools for the rapid assessment of quality of care in MNCAH facilities using innovative methods. Develop innovative methods of monitoring quality of care including user perspectives. Oversee the field testing of the quality assessment tools for monitoring improvements in quality of care in MNCAH facilities in selected countries. Establish a network to monitor quality of care. Manage the publication of periodic quality of care reports in MNCAH. Link the work on quality of care to other global initiatives such as Every Woman, Every Child, and provide cross cutting analysis with coverage data. Establish and maintain effective coordination and communications with other relevant WHO programmes, as well as other UN agencies and partners to harmonize approaches to improving quality of care in MNCAH. Provide key inputs in the organization of global meetings to develop consensus on monitoring quality of care indicators. Promote and support the effective use of health information related to MNCAH, including indicators, health information systems and monitoring and evaluation results. Develop tools and guidelines to support governments and partners in the effective use of health information. Coordinate and monitor status of selected indicators of progress, coverage and quality of interventions and outcomes globally and provide feedback to all concerned. Promote the use of results of monitoring and evaluation to enhance accountability. Develop funding proposals for and support implementation of impact evaluation in MNCAH programmes. Facilitate capacity-building in programme monitoring and provide technical advice to counterparts in member states, providing guidance in monitoring, evaluating and conducting periodic reviews on maternal, newborn, child and adolescent health programmes. Establish and maintain effective communication and coordination with other relevant WHO programmes, as well as other UN agencies and partners engaged in activities in monitoring and evaluation. Assume primary responsibility to ensure that tools and guidelines, including indicators, are technically appropriate and consistent across all groups. Prepare technical reports, scientific papers and documents on programme monitoring and evaluation.

Main achievements include: 1. Periodic global reports on quality of care in MNCAH. 2. Agreed upon coverage and quality of care indicators including user perspectives and methods to measure them. 3.

Monitoring and evaluation data made available to decision makers and used in MNCAH programming. 4. Active involvement in activities within and outside the organization related to monitoring, evaluating, and using data for advocacy, policy and programming. 5. Publications on monitoring and evaluation findings.

REQUIRED QUALIFICATIONS

Education:

Essential: A degree in medicine, or an advanced university degree (Masters level or above) in another health-related field. Postgraduate degree in programme evaluation or epidemiology, with particular reference to developing countries.

Desirable: Training in advanced statistical packages and qualitative research methodology. IT skills in web-based platforms.

Skills:

Ability to develop and build consensus on coverage and quality indicators, methods and instruments to measure them. Ability to monitor and evaluate health programmes. Ability to establish and maintain effective working relationships with international and national staff at all levels. Ability to write concise reports. Knowledge and skills in information technology for monitoring. Knowledge and skills in data management and analyses of large data sets. Knowledge of WHO procedures. Expert knowledge and skills in information technology relevant to monitoring, together with working knowledge of statistical software.
